CHANGES TO INFIGEN'S AUSTRALIAN WIND DEVELOPMENT PIPELINE

Infigen Energy (ASX: IFN) today advises that it has completed a transaction with renewable energy project developer National Power Partners (NPP) in relation to the ownership of certain wind farm development projects in its Australian wind energy development pipeline.

Under the terms of the transaction, Infigen has acquired the remaining 50% interest in each of the following development projects that it did not already own.

Infigen now owns 100% of each of these development projects.

As part of the transaction, NPP acquired Infigen's interests in the 54MW Glen Innes development project in NSW and approximately 100MW of other development projects which were previously being jointly developed by NPP and Infigen. In addition, Infigen made a net cash payment of approximately \$1.4 million to NPP in recognition of costs incurred and development contributions made by NPP in relation to the Bodangora, Flyers Creek, Cherry Tree and Woakwine projects, and in satisfaction of other items that were outstanding between them.

Infigen Energy Managing Director, Miles George said, "This transaction ensures that Infigen has full control over an attractive portfolio of projects which Infigen can progress according to market conditions. When conditions improve these projects are expected to be amongst the highest return projects within our Australian development pipeline."

Infigen and NPP will continue to hold a 32% interest each in the Walkaway 2 and 3 wind farm development projects in Western Australia which total 394MW.
