**BABCOCK & BROWN WIND PARTNERS STAPLED SECURITIES –  
CONFIRMATION OF ALLOTMENT**

Babcock & Brown Wind Partners (ASX: BBW) advises that it has today issued 128,754,789 BBW stapled securities as part of the implementation of the scheme of arrangement between Alinta Limited (“Alinta”) and its security holders (“Scheme”). BBW stapled securities issued as part of the Scheme have been allotted to the issuer sponsored sub register for BBW and the CHESSE sponsored sub register. The total number of BBW stapled securities now on issue is 801,825,671.

BBW stapled securities issued under the Scheme will trade on the ASX today on a deferred settlement basis. Trading for these stapled securities is expected to commence on a normal settlement basis on 3 September 2007.

Consideration Transaction Advices, which confirm the number of BBW stapled securities issued to each Alinta shareholder under the Scheme, will be despatched to BBW stapled securities holders by 7 September 2007.

Any holder who wishes to trade their BBW stapled securities prior to receiving their Consideration Transaction Advice needs to carefully confirm their holding prior to trading by checking with their broker, or contacting the Alinta Offer Information Line on 1800 774 356. Holders who sell more or less than their actual BBW stapled securities holdings before receiving their Consideration Transaction Advice do so at their own risk.
