SUMMARY OF FINAL DISTRIBUTION AND DRP PARTICIPATION

Babcock & Brown Wind Partners (ASX: BBW) confirms that its final distribution of 6.25 cents per stapled security for the 6 months ended 30 June 2007 will be paid to security holders on 14 September 2007.
