## INFIGEN ANNOUNCES SENIOR APPOINTMENTS

Infigen Energy (ASX code: IFN) has today announced the appointment of three senior executives to lead key business functions in Australia.

**Mr Andrew George** has been appointed as General Manager of the newly formed Energy Markets business unit. Andrew will manage Infigen's transition to become a more active and broader energy market participant in Australia including strategies to expand its interests in the market generally and to build its customer base. Andrew was formerly the head of Alinta's highly successful energy business until the Alinta-AGL takeover, and since that time has been a senior commercial advisor to various Australian energy groups including Infigen.

**Mr David Griffin** has been appointed as General Manager of Infigen's Business Development unit. David currently manages Infigen's wind farm development pipeline acquired in July last year, and is also responsible for sourcing other new opportunities for profitable business growth in utility scale renewable energy generation. David has a strong track record in developing renewable energy projects in Australia including leading the successful development of Infigen's Capital wind farm in New South Wales and the Alinta wind farm in Western Australia.

**Mr Scott Taylor** has been appointed as General Manager of Infigen's core Generation business unit. Infigen's business in Australia is in the process of implementing a direct control strategy for operation, service & maintenance, and construction following similar successful initiatives undertaken in Infigen's US business. Scott currently manages Infigen's US wind energy business and has previously been involved in a range of business transition, strategy development and risk management functions for Infigen.

Commenting on these appointments, Infigen Managing Director Miles George said "These three senior appointments represent a further significant milestone in the implementation of Infigen's strategy to secure direct control of its generation operations, and to capture attractive future growth opportunities in Australia. These experienced managers bring complementary skills and experience to the existing senior management team to further strengthen our position as Australia's leading specialist renewable energy business" he said.
